Sense India at a glance - Achievements in last 25 years

Sense International India (also known as Sense India) established on 29th March 1997, is the only national level organisation supporting specialised services which enable children and adults with deafblindness and multiple disabilities to overcome the challenges caused by this unique disability.

Sense India focuses on

- 1. **Health:** Early intervention and Mental Health
- 2. Education: Special Education and Inclusive Education
- 3. **Livelihood:** Vocational Training and Income Generation Activity
- 4. Inclusion: Disability

Over the past 25 years, there have been numerous milestones that the organisation has achieved. Some of the most important being-In 2003, established three national networks of adults with deafblindness (Udaan), parents (Prayaas) and educators (Abhi-prerna) to create an exchange of life lessons, experience and motivation among them. In 2015, Sense India developed the country's 1st adaptive curriculum to include deafblindness in mainstream education and also accredited with a consultative status by the United Nations Economic and Social Council (UN EcoSoc). Through our advocacy efforts 'deafblindness' has been recognised as a disability in the 'The Rights of Persons with Disabilities Act, 2016.

Our Partnerships

Since our establishment in 1997, we took a strategic decision not to open our own centre, but to work with partner organisations and build their skills to address the needs of persons with deafblindness in the community. The approach gave us a free hand to reach out to many civil society organistions across the country and create awareness on deafblindness. At a time when very few people knew about deafblindness, and the challenges faced by them, Sense India's approach to work with CSO partners turned out to be a very resource friendly model. The National Trust addressed the need of publications and training on deafblindness, Educational Consultants India (EdCIL) was instrumental in including children with deafblindness under SMSA in mainstream classrooms, and National Institutes provided us certification and training.

We create opportunities for children and young adults through home, centre based services to learn communication, daily-living skills and receive basic, higher education and acquire income generating skills which lead to family-based income generation activities and independent living.

Laxmi is 9 years old and lives with her parents, siblings and grandfather. Her parents noticed developmental delay in her when she was 2 years old and she was diagnosed with brain tumour at the age of 3. Before joining Sense India deafblind pogramme, Laxmi would mostly lie down and sleep and was not able to do simple activities of daily living or communicate. She has shown significant progress and can stand and walk up to 10-15 steps.

During the second wave of Covid-19, the learning didn't stop with the help of virtual mode of teaching. Laxmi has learned many things, including identifying colours and counting numbers. After Sense India support, she can also hold small objects like pen, rice, beads, ball, sand and sit as well as kneel to crawl independently.





Sania was identified with multiple disabilities soon after birth. Her grandparents and mother brought her up and love her a lot. She couldn't get admitted in a school for the blind due to multiple disabilities and was referred to Sense India's partner-Mathru Educational Trust for the Blind.

She had difficulty in expressing herself and only used gestures for communication. She was given training on communication, using sign language, finger spelling, socialisation and orientation and mobility. Gradually, she was integrated to the hearing-impaired section at Mathru and is now studying in 5th class. Her parents are happy with the improvement in her life and are supporting her in all the ways to complete her studies till 10th standard and they have further plans to send her for higher studies. Heena, her mother said that she was upset about her daughter's deafblindness when she was born but was thankful for the interventions provided by the Mathru programme.



I joined Caritas Goa in 2016 as a senior special educator. I am grateful to Caritas Goa and Sense India for giving me the opportunity to work with persons with deafblindness. With one-to-one sessions and other rehabilitation services, I have seen considerable changes in the lives of the children. The guidance from the Sense India team and work culture at Caritas Goa has helped me grow professionally and personally.

Study on Mental Health



The session on Mental Health was really informative. Earlier I knew that depression and anxiety exist but I learned about the importance of mental health and its need among our children and young adults with deafblindness and multiple disabilities

Mental health is a rarely talked about condition in India and conversations regarding mental health of persons with disabilities are almost non-existent. In this context, no interventions have been carried out till date on the mental health-related issues of children and young adults with deafblindness. Sense India took the first of its kind initiative to assess, provide individualised intervention and support for children and young adults with deafblindness and Multiple Disabilities on mental health issues.

With the funding from Grand Challenges Canada, Sense India is running a two year pilot project with the aim to screen, identify and support children and young adults with deafblindness and multiple disabilities on mental health issues. At the end of the first year of the project, we were able to achieve the following:

Our Advocacy

For the past 25 years, advocacy has been an important part of our efforts for disability inclusion. We have successfully advocated for a variety of issues, from education and health to economic equity of persons with deafblindness. We have worked tirelessly to ensure that every individual with deafblindness, their families have an equal opportunity to thrive in their communities and enjoy the same rights and privileges as everyone else. Our advocacy efforts have made a real impact in the lives of many individuals with deafblindness, and we continue to strive towards a better tomorrow.

Some of the highlights of our advocacy efforts include:

- ⇒ Three National Networks have been formed Udaan, the network of adults with deafblindness having 285 members, Prayaas the network of family members having 1605 members and Abhi-Prerna network of teachers/educators having 890 members
- Ensured recognition of deafblindness in the Rights of Persons with Disabilities Act, 2016
- Rubella vaccination was included in National Immunisation program of Govt of India
- Accorded consultative status with Economic and Social Council of United Nations
- Collaborate with Union ministries and state departments of social welfare, education, health, women and child development in 23 states through partner organisations
- Collaborated with various organisations and international bodies like Deafblind International, International Disability Alliance, Commonwealth Children and Youth Disability Network ensuring Persons with Deafblindness are represented at United Nations Human Rights Council and United Nations World Data Forum.
- Collaborated with initiatives of National Census, Election Commission and Human Rights Commissions to ensure inclusion of persons with deafblindness



Sense International India has done a really good job for children and adults with deafblindness. I joined NAB Nashik through the guidance and support of Sense International India. They suggested that I get myself trained in the field at the Helen Keller Institute. In 2010 I joined National Institute for the Blind Nasik as on assistant teacher. During the year 2021 our work had a bigger impact and influence at various national and international forums. Some of the highlights include:

- Sense India had the opportunity to hold a side event on the topic of "Building back better: The impact of Covid-19 on persons with disabilities in India" during the 14th United Nations Conference of State Parties (COSP14)
- K Prabhakaran, a young adult with deafblindness and member of the Udaan network, received the National Award from Hon. President of India and Ms. Asha Patwal, a young woman with deafblindness was awarded by the Uttarakhand state government on International Day for Persons with Disabilities (IDPD).
- Sense India participated in the Global Disability Summit (GDS) virtually from February 14-17, 2022. Ms. Shrutilata Singh, our Network Specialist along with Ms.Asha Patwal, both young women with deafblindess presented in the Asia region round table on 'Transition to Employment', at the GDS Youth Forum.









Our Response to COVID-19 Pandemic

Covid-19 has been one of the most impactful phenomena which rattled the world since beginning of 2020. The second COVID-19 wave had taken India by storm. It had overwhelmed the healthcare system, leaving hospitals grappling with short supply of medicines and oxygen. Sense International India identified many families of children with deafblindness who were suffering owing to loss of livelihoods during the pandemic and ensured that essential food and ration items were provided to the families.

Covid Relief support in 2021:



2600 Ration & medical kits were distributed to families of the persons with deafblindness and multiple disabilities in 23 states (urban, rural, tribal, remote).



Success Story - I Wrote My Name

At the age of fifteen, Srinivasan had already achieved a lot despite having deafblindness. His family lived in difficult circumstances, which necessitated a lot of convincing to persuade his parents to allow his intervention. Srinivasan had to undergo three surgeries for his cleft palate and was on a liquid diet for such a long period that it became his only source of sustenance. His severe hearing loss in both ears, coupled with his low vision, made him extremely shy towards other people. It took him a while to warm up to the educator, who finally managed to bring a smile to his face. He was unable to hold a pencil or a pen, so it became important to focus on improving his motor skills. Playing with toys was the best way to get him to learn and he also made some friends among the other children at school. His circle of acquaintances had broadened.



The instructors comprehended that Srinivasan needed to learn how to read and write. Thus, utilizing his residual vision, the trainers began to teach him sign language and work on writing by improving his motor abilities. At first, Srinivasan just got words like come, sit, and eat. It was challenging to speculate what he was thinking with his impassive face. Gradually and steadily, he learned sign language and could sign numbers from 1 to 10 and sign a few words including his own name. As he moved from being an eleven-year-old kid to turning into a teen, the educators started presenting him with some prevocational aptitudes, for example, understanding the idea of money and recognizing various denominations of currency. He began helping his dad who runs a little tiffin shop by serving to the clients with a smile. He started showing that he can work too. Srinivasan started opening up. The signs that he realized at the centre with the work he was doing at the shop, the lift of trust in himself was perceptible.

It was like a caterpillar emerging from its chrysalis. He began to greet teachers in the corridor with a grin, and did the same with the patrons in his dad's store. He wrote his name for the first time, drawing the letters of the alphabet with the assurance of presenting a plate of food to a customer-with a sure hand. This was just the start. Srinivasan has transformed into a butterfly and still needs to extend his lovely wings, which he will do with the assistance of his instructors.


